The Counseling Division is operating with outdated equipment and technology. Presently the technology, which includes desktop computers, laptop computers, and printers are more than 12 to 15 years old. Students are not receiving quality service that can be provided by Counseling because of the limitation of outdated technology. We are requesting a TIF grant to provide state-of-the-art electronics; i.e., printers, desktop computers, laptop computers, and monitor.

Detailed Description of Project

Counseling A121 Classroom

The Counseling Division's goal is to provide student services that promote student success and increase positive impact on retention. Updating technology in for A121 classroom will allow precise and expedient services. The Counseling Divison is requesting 20 laptop computers.

The updated laptops will allow student access to material and services for the classroom setting. The laptops available presently for students are outdated and unusable for courses and seminars offered by the Counseling Division. Not having laptops in classroom A121, students are not offered the opportunity to receive the full benefits of the course content.

Career Resource Center (CRC)

Twenty desktop computers will be placed in the Career Resource Center for students who are researching occupations using FOCUS 2 software or other career exploration applications and for students who are doing research for courses. Retention occurs in the classroom. The use of technology in the classroom instruction aids in increasing students' participation and retention.

The CRC is located in the Counseling office. Presently there are 14 computers in the CRC. There is sufficent space for an additional 6 computers. The present computers were installed in 2014.

The CRC serves as a place for students to explore their career paths and examine various occupations that are associated with their choice of major. Also, the Career Services Placement Office shares the CRC for resume development and job searches.

The CRC is open Mondays through Thursdays from 8 a.m. to 6 p.m. and Fridays from 8 a.m. to 6 p.m. and is located in the Counseling and Career Services areas.

Assisted Learning Services

Assisted Learning Services (ALS) will use the computers in the CRC and A121 classroom for nursing students' final exams for graduation. Nursing students' graduation exams are offered and managed by the state of Michigan and requires state-of-the-art technology.

Counseling Waiting Area for Students

Counseling office is requesting a monitor for the waiting area. The monitor will provide students with information specifically related to counseling activities such as waiting time, counseling-related services, etc.

Student Impact

How many unique students will be served each academic year (Fall through Summer) by your project? The term "unique students" refers to unduplicated headcount. Provide detail (course numbers; titles; and enrollments, for example).

3000 - 3500 unique students use the CRC. In light of the number of students per our data, students from various academic programs will access and benefit from use of the computers.

Not having laptops in classroom A121, students are not afforded the opportunity to receive the full benefits of the courses' content. Faculty can provide content-enriched presentations, and students can participate in online seminars in the classroom with new laptop computers.

Assisted Learning Services (ALS) will use the computers and laptops for nursing students' graduation testing.

Counseling and Student Outreach Services (SOS) will use both computers and laptops for workshops and seminars and offsite workshops.

Students will able to:

- * Access computers to schedule appointments online
- * Check in for appointments
- * Use laptop computers in classroom for seminars, workshops, and classes

A training module will be developed for students who have not taken an online course or need assistance with taking an online course. Students will also receive assistance from a counselor.

Explain how the project promotes curricular revision.

The college plans include an increase in online course offerings. However, many students who desire to take an online course are unable to so because of outdated computers or no access to computers and/or to the internet in their homes. CRC computers will allow the accessibility for those students. The Counseling Division offers three online courses: Coun 125, Coun 120, College 101. College 101 was recently added as a 50%-hybrid class. Several college departments increasingly are offering 100% online or hybrid courses for which students can use the computers in CRC for access.

You or someone familiar with your project should plan to attend that meeting to answer any questions Board members may have.
- 5. The Board of Trustees will not actually vote whether to allocate funds for your project until the meeting following the meeting at which your project is discussed. The Board generally does not ask further questions about projects during the meeting in which it takes the vote. The Technology Investment Committee Chair will notify you of the outcome of the Board's vote.
- 6. Assuming that the Board votes to allocate funds to your project, you will work with the Office of Financial Services and Auxiliary Services and with Purchasing to use your funding to complete your project. (A copy of your proposal will be forwarded to the Purchasing Director.) You are responsible for coordinating the work to be done to complete your project including any tasks required during the Spring and Summer semesters.
- 7. During the third full semester (Fall or Winter semester) following the semester during which your funding is awarded, you will be asked to provide a written report evaluating your project and to present this report to the Technology Investment Committee.
