Upgrade computers used for classes and those used by students in the Eshleman Library:

- *G-337: Health Sciences HCS-131 classroom – 25 computers*
- *Library Reference – 21 computers*
- *Library Media Center, back of lab – 35 computers*
- *K-125: English classroom - 26 computers*
- *G-125: Health Sciences classroom – 31 computers*

- b. Why do you propose to do this?

These computers are amongst the oldest on campus and are in need of an upgrade to improve teaching and learning. Purchasing new computers will ensure the latest operating systems and improve the processing speed.

2. How many unique students will be served each academic year (Fall through Summer) by your project? “Unique students” refers to unduplicated headcount. Provide detail (course numbers, titles, and enrollments, for example).

Thousands each semester:

- *G-337: is a computer lab on campus used by HCS-131 students. It is open 8 am – 9 pm, Monday – Thursday. We run approximately 5 sections each day in this room, and approximately 10 each semester.*
- *Library Reference: Used by hundreds of students each day.*
- *Library Media Center: Used by thousands of students each week.*
- *K-125: Computer lab used for English classes, generally ENG-135. Room is generally booked every day, every hour. This semester, there are 15 sections in this room (370 students).*
- *G-125: is a computer lab on campus used by HCS-131 students, EMS students, and coding. Enrollment varies, but there is 1 coding section, 1 EMS section, and 3 HCS-131 sections.*

 - *Total approximate cost: \$156,630.00*
